#### AJC CEO Ted Deutch, Second Gentleman Doug Emhoff Call for Unity Among American Jews at Heartland Antisemitism Summit

Despite feelings of vulnerability in the wake of the Hamas massacre in Israel on Oct. 7, American Jews must remain united and never stop being proud of who they are, American Jewish Committee (AJC) CEO Ted Deutch said.

"Especially in a post-10/7 world, being silent is not an option. Hoping others will stand up for the Jewish community is not enough," Deutch said. "If we speak up and speak out, it makes it easier for our allies to be there with us."

Deutch spoke recently during a fireside chat with Second Gentleman Doug Emhoff and Gavriela Geller, Executive Director of JCRB|AJC at Driving Out Darkness in the Heartland, a summit on countering antisemitism co-sponsored by the American Jewish Committee. The first-of-its-kind meeting of 400 Jewish leaders, educators, local officials, and community activists from various faiths featured sessions on best practices for addressing antisemitism in the Midwest, including rural areas.

The symposium was held three days after the 10th anniversary of the hate-driven murders of three individuals outside of the Jewish Community Center of Greater Kansas City and Village Shalom in Overland Park, KS. The gunman was a white supremacist intent on killing Jews, though none of the victims were Jewish.

"This is not a Jewish issue. This is not a Democratic issue. This is not a Republican is-

sue. This is an American issue," said Geller, executive director of JCRB|AJC Kansas City, which organized and hosted the full-day summit

"We have all seen the impacts to a society when antisemitism is allowed to grow, and it threatens our American values of pluralism, of democracy, of the things that make us proud to be American."

Hundreds of Young Jewish Business Leaders from North America, Israel, and Other Countries Gathered at Excel Fellowship Summit in New York



During the first weekend of April, nearly 400 Excel Fellows from North America and around the world gathered in New York City, for the Excelerate24 Summit.

Excel is a lifelong, global business fellowship, part of Birthright Israel, that identifies and brings together the next generation of Jewish business leaders. After completing a summer business or tech internship in Israel, the Excel community provides immersive opportunities in professional development, networking, personal growth, Israel engagement, and Jewish identity.

After their internships, Excel Fellows have maximized their experiences by taking on positions at toptier companies such as J.P. Morgan Chase, Bain & Com-

pany, and Google, developing strategic partnerships with Israeli companies, and starting their own companies, often hiring other Fellows.

The Excel Fellowship has grown tremendously with the number of applications for last summer rising +80 percent from the prior year. This year has also brought further global expansion with the addition of Germany and Switzerland among those selected for the upcoming summer cohort. Since Excel began expanding beyond North America, 16 countries have been represented.

#### Local Authors Share Unique Family Histories from New Book on the Holocaust

A group of local Westchester County area authors of the recently released book Testaments of Courage in the Holocaust appeared live on Zoom last week to share detailed history of their families' experiences during WWII under the Nazi regime. Testaments of Courage in the Holocaust is a compilation of true stories told by authors comprised of second-generation Holocaust survivors that describes the courage and resilience of their family members who escaped the Nazis' final solution.

The Holocaust & Human Rights Education Center (HHREC) hosted and produced the event offered as part of their Memory Keepers Story Hour series. The authors who appeared included Michelle Griffenberg and Gloria Lazar from Tarrytown: Joan Poulin from Somers: Melanie Roher from White Plains; and Helen



Rubel from Irvington. The authors of the book are all members of the HHREC GenerationsForward Speakers Bureau, a second and third-generation group that includes children and grandchildren of Holocaust survivors who appear at area schools, synagogues, churches, and other community events. HHREC Memory Keepers are trained speakers who tell their family's story from their next-generation perspective, adding new meaning to the survivors' powerful

In response to the release of the Anti-Defamation League's (ADL) audit of antisemitic incidents in 2023, Hadassah National President Carol Ann Schwartz recently released the following statement:


"As the largest Jewish women's organization in the country, Hadassah is deeply troubled by the documented steep spike in antisemitism in the last year. A 140% increase in reported antisemitic assault, harassment, and vandalism incidents in 2023 is beyond alarming. We are, as ever, committed to standing up to antisemitism

everywhere, advocating for change, and empowering Jewish women to take pride in and celebrate their identities. This rising tide of Jew hatred affects people, especially women, every day in big and small ways, and, as we have seen, is dangerous. We call on leaders at all levels across the US and around the world to take these warnings seriously and work to counter the world's oldest form of hatred."



Hadassah, The Women's Zionist Organization of America, is the largest Jewish women's organization in the United States. With nearly 300,000 members, donors, and supporters, Hadassah brings women together to effect change on such critical issues as ensuring Israel's security, combating antisemitism, and promoting women's health care. knowledge is power when it comes to fighting antisemitism. On that account, she said the Midwest has done well, citing statistics from AJC's State of Antisemitism in America 2023 Report, which found that nearly 70% of adults in the Midwest knew a Jewish person.

"We know that if you know someone who is Jewish, you are more likely to recognize antisemitism, to know it's a problem, to know it has increased, and what it looks like," Huffnagle said.

Geller said the fear in the Jewish community is real, especially since the Hamas massacre of 1,200 men, women, children, and babies in Israel on Oct. 7. Since then, she has heard questions she never thought would need to be asked, let alone answered.

"When will we know it's time to leave? Should we have a bag packed? Should we buy property abroad?" asked Geller. "I was at Shabbat dinner just two weeks ago, and a young couple with a new baby was talking about building a house. And our host asked them, 'Are you building a safe room?"

Two of the victims of the Overland Park shootings were the older son and father of Mindy Corporon, who delivered opening remarks at the symposium.

"I feel like it's been my responsibility since losing my dad and son at the Jewish Community Center to let everyone know, ev-

erywhere I speak, that hate does not discriminate, but neither does kindness," said Corporon, co-founder of SevenDays, whose mission is to overcome hate by promoting kindness and understanding through education and dialogue.

Along those lines, Deutch said in times of tragedy, be it Overland Park or the Hamas massacre, the strength and resilience of the Jewish community come to the fore. He cautioned that Jews-in the Midwest and beyondneed to stand firm in the face of that adversity.

"Since October 7, there has been a sense of unity that exists, largely stemming from the realization that the community – as it felt on October 7 and was reminded over the weekend (following Iran's attack on Israel) – faces real vulnerability. To confront that vulnerability, we must stand together," Deutch said. "And we must be proud to be Jewish."

several others from Italy, the UK, Spain, Australia, France, Argentina, Mexico, and Canada, joined their U.S. peers for Excelerate24, cementing those bonds.

Throughout the weekend, participants took part in global networking opportunities and industry-specific panels on topics from Impact Investing to Climate Tech to AI and the evolution of venture capital, each led by Excel Fellows themselves who are rising stars across a wide range of business and tech fields. Also, topics such as business development, Jewish identity, and Israel engagement were integrated into several Excel Fellow-led panels.

This year, a reflection on the horrors of the October 7th massacre by Hamas was a central element of the three-day Excel Summit.

Sunday included a touching speech given by Moshe Lavi, whose brother-in-law Omri Miran is being held hostage in Gaza. Additionally, there was a panel named Six Months of Strength & Survival, which featured Excel Fellows who are IDF reservists and shared the combined impact of their experience as both civilians and then serving the country.

Sunday also featured presentations by three recognized leaders in the world of business, global health, and media. Anton Levy, Co-President, Managing Director, and Chairman of Global Technology Group/General Atlantic; Professor Yitshak Kreiss, Sheba Medical Center Director General; and Avi Mayer, The Jerusalem Post former Editor-in-Chief.

Professor Kreiss from Sheba Medical Center, named by Newsweek as the #9 hospital in the world,

shared his experience and wisdom leading Sheba during this most challenging time. "Of the 1,487 wounded soldiers who came to Sheba since Oct 7th, only two didn't survive. That's a remarkable accomplishment and makes for an unprecedented survival rate of 99.85%," Kreiss said. "As a leader, if you raise the bar high and your team buys in, they will raise the bar even higher."

Since 2011, Birthright Israel Excel has been engaged in developing the next generation of Jewish business leaders. The Excel Fellowship selects extraordinary college students from around the world for a summer business or tech internship in Tel Aviv at leading companies. After their return, Excel Fellows become part of a global community that provides resources for professional and personal development and Israel engagement, while also being dedicated to philanthropy.

"The Birthright Israel Excel program is considered to be the most prestigious program in the Jewish world today, with only a few dozen young people being accepted from thousands of applicants. This year we received applications from 25 countries," said Gidi Mark, CEO of Birthright Israel. "It was heartwarming to see the global Excel business community launch initiatives supporting Israelis and young Jews worldwide post-October 7. Birthright Excel Fellows are active every day as recognized leaders in their professional arenas and within the broad Jewish community and it's our goal to continue guiding and supporting them in their efforts to build a thriving and better Jewish future for all."

# Becoming Janet: Finding Myself in the Holocaust

A child survivor of the Holocaust and a clinical social worker, Janet Singer Applefield has spent over 40 years speaking with thousands of students, educators, religious groups, government officials, and librarians to raise awareness and understanding of the dangers of prejudice while encouraging audiences to stand up to any kind of discrimination and injustice.

In her engaging and touching memoir, Becoming Janet: Finding Myself in the Holocaust [Cypress House / May 7, 2024], Janet shares her story of trauma, and the trauma experi- Janet Singer Applefield enced by her family, and

provides a powerful and personal connection between the past and the present. A testament to the enduring strength of the human spirit, family, and, above all, hope, this is a Holocaust survival

story about discovering one's true self and how that is - and sometimes isn't connected to what we see as our "identity."

As a young child growing up in the Tatra mountains of southern Poland, Gustawa Singer lived an idvllic life. Her parents doted on her, and she was surrounded by loving relatives. When Hitler's army invaded Poland in 1939, however, everything changed. Gustawa's carefree childhood days were gone forever. Ultimately, the Nazis killed over 2,500 of the 2,762 Jews in her small hometown. Gustawa's mother was transported to the death camp at Belzec, and her father was assigned to slave labor. Separated from everyone she had ever known,

Gustawa assumed a false name, that of a deceased Catholic girl her own age.



Amidst the Nazis' appalling savagery, a compassionate stranger spotted Gustawa after her "caretaker" cousin was arrested by the Gestapo in a raid in Krakow. At terrible risk to her own family, the kindhearted woman took her in and fed, clothed, and loved her. Gustawa survived and was eventually reunited with her father, who had never stopped searching for her. They emigrated to the United States where, believing that the world must never forget the horrors unleashed by Hitler's regime, the woman who grew to become Janet Singer Applefield dedicated her

life to sharing her emotionally charged journey of heartbreak and overcoming the most unthinkable of adversities.

Nowadays, Janet speaks openly about her experiences with thousands of people each year

through regular speaking engagements. In 2021, she was invited to tell her story before the Massachusetts State Legislature, on the occasion of the passage of Bill H.692, an act mandating statewide genocide education in all middle and secondary schools.

At 88 years old, Janet continues to be an avid reader and international traveler. She has three children and five grandchildren and lives south of Boston, MA.

Becoming Janet: Finding Myself in the Holocaust will be released on May 7, 2024, and will be available at bookstores and online retailers. At its core, it's a story, at its core, of hope, survival, the

forces of good and evil, and, most importantly, love - the love of family, of our background, and oneself.



#### State Senate Majority Leader Andrea Stewart-Cousins and State Senator Shelley Mayer Announce New Laws to Combat Retail Theft and Crack Down on Illicit Cannabis Shops in Adopted State Budget

New York State Majority Leader Andrea Stewart-Cousins and Senator Shelley B. Mayer announced last month that the FY 2024-2025 New York State Budget provides resources to police, prosecutors and small businesses to combat retail theft and crack down on illicit cannabis shops. Included within the budget were the following new provisions:

Assault of a Retail Worker: Creates a new class E felony of assault of a retail worker. A person is guilty of assault on a retail worker if they cause physical injury to a person whose usual workplace is a retail establishment, while they are performing a task within the scope of their duties, with the intent of preventing them from performing said duties.

Larceny Aggregation: Allows prosecutors to aggregate the cost of stolen merchandise over multiple offenses if there is a single, ongoing criminal intent. A person found guilty with \$1,000 in total stolen value can be charged with larceny in the 4th degree, a class E felony; a person found guilty with \$3,000 in total stolen value can be charged with larceny in the 3rd degree, a class D felony; a person found guilty with \$50,000 in total stolen value can be charged with larceny in the 2nd degree, a class C felony; and when a person if found guilty of \$1 million in stolen value they can be charged with larceny in the 1st degree, a class B felony.

Fostering the Sale of Stolen Goods: Creates the crime of fostering the sale of a stolen good; a class A misdemeanor.

Tax Credits for Small Businesses: Provides a commercial security tax credit to businesses with 50 employees or fewer that have at least one physical retail location in New York State. Businesses with fewer than 25 employees are eligible to receive a tax credit if they spend more than \$4,000 on security expenses within the last year; and businesses with more than 25 employees are eligible if they spend more than \$6,000. Eligible businesses can claim up to \$3,000 per location.

Shutting Down Illicit Cannabis Shops: Provides new tools for local governments to establish their own local laws to shut down illicit cannabis stores, seize products and impose civil penalties.

Majority Leader Stewart-Cousins and Senator

Mayer were joined by County Executive George Latimer, Yonkers Mayor Mike Spano, Deputy County Executive Ken Jenkins, and President of the Retail Council of New York, Melissa O'Connor.

Senate Majority Leader Andrea Stewart-Cousins said, "Through decisive action in the State Budget, we're equipping local law enforcement with the necessary resources to combat retail theft and eradicate illicit cannabis shops, safeguarding both our communities and our economy. These new measures affirm our commitment to protecting our local businesses and ensuring the safety of both retail workers and consumers. I am proud to have led the Senate in the passage of these budget measures, and to stand with Governor Hochul and Speaker Heastie in prioritizing the safety and prosperity of all New Yorkers."

State Senator Shelley B. Mayer said, "I am proud New York is taking action to address the ongoing challenge of persistent retail theft and illicit cannabis sales. The budget passed this year provides prosecutors and police with the tools necessary to crack down on retail theft and illicit cannabis shops, keeping New Yorkers safe and giving businesses the tools necessary to support and grow their stores. I thank Majority Leader Stewart-Cousins for her leadership and dedication to protecting New Yorkers and I thank our local leaders and law enforcement for working with us to find the appropriate measures to address these challenges."

Melissa O'Connor, President and CEO of the Retail Council of New York State said, "On behalf of thousands of stores in New York State, I want to thank the Legislature, Executive, district attorneys, and state and local police for listening to the concerns of business owners and employees. As a result of consistent collaboration among all stakeholders, including the Senate Majority Leader and Senator Mayer, New York will soon have new laws and related funding to address organized retail crime and habitual retail theft. The retail industry will continue our work with community leaders to ensure a safe shopping environment for all New Yorkers, including those in Westchester County."

## WJCS Programs and Services Since October 7

The October 7 massacre committed by Hamas terrorists in Israel has stung all those in our Jewish community. The shock, the sadness, and the fear have affected all of us, whether we have relatives in Israel, are part of the American Israeli community, are members of the Jewish community, are allies of Israel, or are just plainly appalled at the barbaric savagery and kidnapping that took place.

Since October 7, the Jewish Programs division at Westchester Jewish Community Services (WJCS) has been actively supporting youth, adults, and the elderly during this frightening and devastating period in a myriad of ways. The need is great and, as we have done since our founding in 1943, we are here to help in as many ways as we can.

WJCS partners with over 25 synagogues, Jewish nursery and day schools, JCCs, and assisted living facilities. Our focus has been on addressing mental health and building resilience, which includes offering education about trauma and coping skills. We have provided on-site support to day school teachers and staff, many of whom are Israeli and/or have family in Israel as well as the IDF. We've spoken with parents who are concerned about how to talk to their children about the conflict and the rise of antisemitism. WJCS is on call to our Westchester clergy partners to assist with the needs of their congregants. And we have

increased support for our most vulnerable population - our Holocaust Survivors. We added daily phone calls, special meal deliveries, and volunteer visits to our services in order to reduce the Survivors' sense of isolation.

Our WJCS social workers have provided individual and group counseling to individuals as well as workshops to organizations, such as The Forward and Haddasah. Throughout these trying months we have continued our regular programming of Caregiver and Bereavement Services with the addition this year of two new groups at the JCC of Mid-Westchester. Our support of Alzheimer's family caregivers continues, with multiple caregiver groups and individual counseling. Membership in our Shelanu and Supper club programs has doubled since last year and continue to have creative, educational, and fun programming for young adults on the autism spectrum. These events now include the participants of our group homes and POINT program.

At WJCS, we work as a team to support our clients, providing a vast array of services and programs to Westchester residents of all different ages. If you (or someone you love) are having trouble coping during this challenging time, go to wjcs.com and review the various ways our agency can help. #### Guardianship Can Be Expensive

With the recent news concerning several high-profile individuals being subjects of guardianship, we thought it would be a good idea to discuss how expensive guardianship can be and what you can do to avoid it.

If there is someone who you care about who is having difficulty managing their personal or financial affairs, they may need a guardian. Guardianship in New York is supposed to be the least restrictive form of intervention for a person who cannot manage their own affairs. However, the least restrictive does not necessarily mean that it is not expensive.

Here's a summary of the expected costs:

1. When you file for guardianship for someone else, the legal papers you and your attorney draft must be filed with the court and served on the person you are seeking guardianship for. The court filing fees and process server fees can run several hundred dollars.

2. Your lawyer's fees will be several thousand dollars, and up, especially if you hire an experienced guardianship law firm to represent you. However, if your case is contested then the fees will be much higher. For example, if you file a guardianship petition seeking guardianship of your mother and your brother hires an attorney to contest the guardianship in any way, then all bets are off as to what the guardianship will cost. Among other things, your brother may claim that mom does not need a guardian, or he may disagree with you as to who the guardian should be. This is called a contested guardianship, and there is no way to predict the total costs involved. Suffice it to say that it will cost much more than an uncontested guardianship proceeding. Your legal fees will be your responsibility regardless of how the proceeding turns out. In some cases, your legal fees can (subject to court approval) be reimbursed from the incapacitated person's resources if you are successful in obtaining guardianship. However, most lawyers will expect to be paid out of your funds while they are working on the case, and not wait until someone has been appointed guardian who has access to the incapacitated person's funds to pay certain expenses, including legal fees.

3. In addition to your own lawyer's fees, the court may appoint an attorney for the person you are seeking guardianship for. These fees can be several thousand dollars. Fortunately, in most uncontested cases, there usually is no need for a court-appointed lawyer.

4. The court evaluator is someone else who is appointed by the court to be the eyes and ears of the court and who files a report with the court describing your family member's circumstances. In most cases, this person is a lawyer despite the fact that this person does not necessarily perform a legal function. The cost for that investigation and report is frequently in the range of a couple to a few thousand dollars.

5. If someone is appointed guardian of the property, they are typically required to obtain a bond. The premium for this insurance policy can be paid from your family member's assets. The cost of the bond varies by the size of the estate being managed.

As you can see, the fees can add up pretty quickly. Moreover, if the guardian needs legal assistance after the appointment, there could be additional fees incurred, depending on the complexity of the guardianship.

If you and your family are interested in taking the necessary steps to try to avoid guardianship, make sure you and your loved ones have executed advanced health care and financial directives such as a health care proxy, living will, and durable power of attorney. In addition, you should discuss your wishes with the people you appoint as your agents under these documents. By taking these steps you will reduce the likelihood that guardianship will ever become necessary. Nevertheless, sometimes guardianship becomes necessary even if you have taken care of your estate planning in advance. For example, if the person you appoint as power of attorney is not doing their job properly, someone may commence a guardianship to try and have the power of attorney revoked.

While guardianship can be expensive, there are things you can do to minimize the likelihood that your family will go through this process. As part of your overall estate plan, make sure you take the time to think about who you would want to manage your affairs if you can no longer manage them yourself. This can go a long way towards saving your family a lot of money and heartache.


